Winds of Change

The recent local election outcome (see page 2) is a reminder of the dynamic changes underway in Whitestown. One need look no further than Main Street to see evidence of the winds of change sweeping

through town. Changes on Main Street over the past year have included new ownership of the Whitestown Market, closing of Merrill's Barber Shop, opening of Shrack Daddy's Pizza (page 3), sale of the old fire station, Town Hall's lease agreement and possible future purchase of the old fire station (pages 4 & 7), expansion of LA Cafe, change in ownership of LA Cafe (page 15), rezoning approval for a craft workshop/used car dealership at the site of the old post office (page 7), and the closing of Jump's Crossing and subsequent listing of the property (page 3).

Recent changes at Town Hall include the resignations of Town Council member Scott Abbott (page 7) and Clerk Deana Harter (effective December 1). The newly elected Clerk-Treasurer, Judge of the Town Court, and Town

Council members will assume their new roles on January 1, 2004.

The Whitestown Police Department now has a part-time paid officer, Dan Boutwell, in addition to Marshal Ralph Roberts and the reserve (volunteer) officers. The Worth Township Volunteer Fire Department has been giving consideration to the addition of paid standbys (paramedic and EMT firefighters) to their crew.

The Parks Board and the Lions Club have each secured grants, making possible the purchase and installation of new playground equipment at both Panther Memorial and the Lions Club Park. More improvements are in the

works for both parks.

On the outskirts of town, Walker Farms is rapidly taking shape. Construction is ahead of schedule, with 103 homes in progress. Walker Farms is the largest approved subdivision in Boone County (1000+ homes). To date, 55 families have moved in.


The Town of Whitestown is stepping up to the plate with a plan to acquire Boone County Utility (page 8). This would enable Whitestown to expand its

utility coverage area to include the 600-home Royal Run subdivision.

In the midst of changes, it is important to stop and reflect on Whitestown's history...the recent passing of Donald Small, former principal of Whitestown High School, evokes fond memories and serves as a wake-up call that the time we have left to evoke positive changes on earth does have a limit...

With all of the ongoing changes in Whitestown, communication has become increasingly important. This is an inopportune time to be without the Newsletter). A volunteer is needed ASAP in order to provide uninterrupted coverage for the town (page 11).

Meeting Minutes October 14, 2003 Submitted by Deana Harter

At 7:30 p.m., Scott Abbott called the meeting to order. Role call was taken; Scott Abbott, Mike McQueen, and Carla Jackson were all present. Attendees: Kathy Graham, Deana Harter, Christine Atkinson, Darin Garrett, Ralph Roberts, Debra Zachelmeyer, John Zachelmeyer, J.B. Symons, Bill Walker, JoAnn Bennington, John Allen, Mildred Simpson, John Simpson, Robin Maynard, Linda Hunt, Jerre Albright, and Estelle Albright.

NEW BUSINESS

J.B. Symons spoke about Prepaid legal. He explained how the program works and the benefits.

Regional Sewer Territory

Carla has spoken with the County Council; she will attend their next meeting. She will notify them they are planning in our district. They are filing for a sewer territory in our district. This has been in our Master Plan for 20 years.

Status of Town Hall Building

Carla faxed Mark Robinson about purchasing the building. An agreement was made last week. We need two independent appraisals. We are constrained that we cannot pay more than \$77,500. Randy Schaffer asked why we didn't buy this building during the auction. Mike explained some of our other plans have fallen through. Christine Atkinson will send Mark Robinson an offer requesting a written reply. Christine will send him a letter by the end of the week. Mike made the motion to send a resolution from the Town to Mark Robinson. Carla seconded the motion. Unanimous vote ensued. Carla made the motion we purchase the appraisals from the Township. Mike seconded the motion. Unanimous vote ensued.

Carla asked John about the pole in the pull-off at Walker Farms. Mike asked about inspections. John said he is watching. Mike asked about the wire and what gauge the wire is (14-gauge wire in the bathrooms and kitchens?); John said he would speak to Lynn Boyer tomorrow and find out.

MARSHAL: Ralph Roberts

Ralph spoke about the new car. They are waiting for the equipment to be installed. He is selling the '96 for \$5000 with all of the equipment.

WATER & WASTEWATER PLANT STATUS: Darin Garrett

Darin said we will be online with the new water plant this Thursday. As of yesterday, the punch list is mostly completed. The certificate of completion will be done. October 24 is when this should all be completed. They have been paid 97% at this time. If this is not completed by October 24, we can go after liquidated damages of \$500 per day. Mike said Carla has put over a thousand hours into this. Carla gave Chris Herrick credit for helping the Town with this project.

Darin said Troy (Steven Troy Ellis), our new water operator, will be here Thursday for the start-up. Troy works here five days a week. Kathy said Chris will submit a bill for his consulting during this time period.

Darin stated the electric bill has gone down. The Walker Farm lift station is online now. This bill is quite high; we are waiting for more homes to go on before we can do something to lower the bill.

Carla asked about the painting that needs finished at the new water plant. Darin said he will get on this.

Carla asked Darin to check with Tom or Jim from Triad about grading and seeding around the well.

PARKS UPDATE: Marta Haza

Marta spoke about the park. The two spring ride-on toys that were planned to be returning to the park are not going back in; they will need to be replaced. Marta made the agreement to pay the company that did the work at the park. We will pay them 80% of the remaining bill. We have given them the \$10,000 deposit. The remainder of the bill currently is \$4,757.60. We need to write a check for 80% of that, to equal \$3,689.44. The Town park made the front page of the *Lebanon Reporter* today. Carla's kids were at the park and were in the picture.

Everything north, east and west in the park has been graded and reseeded.

WHITESTOWN BOARD OF ZONING: Estelle Albright

Estelle said there will be a Zoning Board meeting November 3 at 7:00 p.m.

Someone wants to put a mobile home in Town, and they want information on the setbacks.

Boone County Utility (BCU) and the Town of Whitestown

As everyone has probably already read in the newspaper, Whitestown is positioning itself to assist in the ongoing Boone County Utility problem. The involvement of Whitestown started when the County Commissioners filed a petition for a regional sewer district that would come very close to, and is in some areas into, our corporate limits.

When I found out about the filing, I immediately went to the County Council and objected to the filing. Any regional sewer district that Whitestown does not have the involvement of forming may prevent Whitestown from ever growing our corporate limits in that direction. This is a big deal.

The fight over BCU has been ongoing for several years and has so many details/problems that I could never state all of them. There are several investors that are owed money, and it is in the hands of the bankruptcy court. If the utility goes for auction, every utility in the state will be invited to bid. This could be a disaster, depending on who takes it over.

There are several "big" players currently trying to solve the problem. Boone County, Whitestown, the City of Indianapolis, and Clay Regional (and at one time, Valenti-Held) are some of the players involved. Valenti is the largest creditor owed in the suit. The biggest objective of most is to get the BCU problem solved before it gets to auction. That can happen in many different forms. What I have seen as the biggest problem is the unwillingness of people to work together and trust one another. I have been in many meetings, and trust is one of the largest issues.


With everyone's issues in mind, Jim Frazell, Steve Brock and I, along with the assistance of Valenti-Held, put together some numbers and created a plan to solve everyone's problems, including the County Commissioners. This plan was discussed by all parties and was put into forward motion on Wednesday, November 12, 2003.


A thumbnail sketch: Whitestown and the County Commissioners will partner together to make an interlocal governmental agreement. Whitestown will be the purchaser of BCU and pay off all the creditors. There will be a five-member board formed to run the utility outside of Whitestown's corporate limits. The Board will be made up of two seats selected by Whitestown, one seat by County Commissioners, one seat by County Commissioners, one seat by County Council, and one seat by the Township. The utility will be a self-funded utility. That means all money collected by the customers will pay the debt, and any money spent on infrastructure will be kept within that utility. This will allow the County to keep ongoing talks with Duke on tax incentives and other major issues to be able to attract someone like them. It will reduce rates in BCU's area, it will allow Whitestown the ability to grow in the future, and it will pay all creditors currently on file at the bankruptcy court. There are many other benefits to the plan that will help everyone.

Our new utility attorney, Chris Janock, and the attorney for the County Commissioners are now trying to get the agreement put together. This will be good for everyone.

I must state, things are always subject to change with this problem. It has seemed that every day brings a new dawning. Things have seemed to change daily, and new twists have come about without warning. For now, this is the direction all parties have agreed upon and the direction we are heading.

There will be an update at the next Town Council Meeting, December 8, 2003, at 7:30 pm.











Dan Cornelius, founder of LA Café, recently sold the restaurant to the father-son partnership of Leland & Leland. As of November 3, Jay and Ben Leland are the proud owners of LA Café in beautiful downtown Whitestown. They



will continue to lease the building at 4 South Main Street

from Larry Averitt.

Ben Leland has been a chef at LA Café since its inception. His father, Jay, grew up in the restaurant business near Plymouth, Massachusetts, which accounts for his passion for seafood. Accordingly, the Lelands are planning to eventually enhance the seafood selection on the menu. They will be implementing changes on a gradual basis, starting with improvements in service and expansion of the kitchen. They have hired a General Manager, Mike Beal, to oversee reservations and seating and to keep things flowing. It should be noted that they are honoring all gift certificates purchased under the previous ownership.

For the time being, the menu at LA Café will remain basically unchanged, with specialties of the house continuing to be shrimp cocktail, steaks, and seafood. However, the wine and beer lists are being enhanced, and the servers are suggesting "featured wines" on weekends. In addition, the café will soon be serving fresh-ground coffee from a local roaster, Evans & King of Zionsville.

The Lelands have already made a few aesthetic changes. most notably the replacement of gold napkins with black ones. The black napkins, coupled with white tablecloths. now portrays a look of pristine, striking elegance. (It is worth noting that both Jay and Ben both embrace the


philosophy that "cleanliness is next to godliness.")

The new addition to the café, which is designated as the nonsmoking section, now boasts a plasma T.V. Plans are in the works to relocate the ice machine in order to cut down on extraneous noise in that section. "Don," as he expected his OLD students to call him, passed away Oct. 27 at a hospital in Beech Grove. He was 81.


Needless to say, we were expecting to see him at our next reunion in 2005. He was like a classmate. He'll be missed.







What kind of instruction did you receive as a child when borrowing something from a friend or neighbor? Were you instructed to: Use whatever you borrowed carelessly, don't worry about when you get it back to them, or get it back to the owner as soon as you could? I'm sure we all have different answers. Some of us may not have received any instruction in that particular area. My instruction was to borrow, use it for what was needed, and return it. It wasn't until my adult life that I learned from two different elders that when I borrowed something, I was to return it (if possible) in better condition than I received it. I have tried to apply the latter learning in adulthood; not always accomplishing it, but trying nonetheless.

If we live under the Genesis precept that one of the central purposes for man being created was that God had given everything to man, with the intention of him ruling, cultivating, and keeping the garden in the original condition that God provided, then we must understand that God's intention is only a temporary job. In other words, we are just using or borrowing what God has given us, and caring for it for a short period of time; eventually, we will have to give it back. The question is, how are we going to give it back?

Jesus makes an observation in Mark's gospel chapter 12, verses 41-44, about watching people of two very different classes as they put money into the temple treasury. The very rich were putting in large amounts, and in their midst a poor widow makes her way up to the treasury jars and puts in two very thin, small copper coins totaling a mere penny. Jesus then tells His disciples, "Truly I tell you, this poor widow has put in more than all those who are contributing.... For all of them have contributed out of their abundance; but she out of her poverty has put in everything she had, all she had to live on."

I believe this widow's strong faith in God was the very reason why she gave everything she had. She believed that

everything she had came from God, and all she was doing was returning it. In Frances R. Havergal's hymn, "I gave my life for thee," Jesus is speaking in the verses to the singers themselves. The last verse goes, "And I have brought to thee, down from My home above, salvation full and free, My pardon and My love. I bring, I bring rich gifts to thee, what hast though brought to me?"

God has given us His very best; He gave us His Son as an atoning sacrifice for our sins. Since everything we have has come from God Himself, can we not in return give Him our very best? Prayerfully consider how this might apply in your own life; be you rich, be you poor, be you gifted or not; are you giving your best?





RACCOONS

They're gone...... For the most part?

Second Installment in a Series (see February 2002 Newsletter for Part 1) Joe Trembley is a retired chimney sweep well known to many homeowners in the Whitestown/Boone County area.

Most folks know about those furry little animals with the mask around their eyes. Raccoons are by far one of the cutest animals nature has given us, but they are probably one of the most ferocious little buggers in the wild. You really cannot trust a raccoon, especially when their young pups are around. They're very protective of their young, and they will hiss and bark at the first sign of danger to their family. If ever confronted by a raccoon, never turn your back on them as I have been stalked many times on a roof at night by them.

At this time of year, raccoons are in or going into hibernation for the winter. Many times I've gone to clean a fireplace and, as usual, I look up into the fireplace for unseen dangers, such as animals. I've taken out of chimneys and fireplaces, besides big and small raccoons, screech owls, barn owls, cat babies, toys, money, tools, tennis shoes, chipmunks, and all kind of birds, big and small, which I sucked up into my vacuum.

Raccoons and squirrels were by far the hardest and most ferocious of all to take out by hand. Very tricky and you had better be very fast and quick-of-hand to do the job right. Raccoons are considered part of the cat family. Their claws are razor sharp. Their claws are used to fight mostly, but they bite as a last resort because their claws are about an inch or more long and they usually do the trick with their claws.

I've heard of a chimney sweep in California who put an arm up into a fireplace smoke chamber and pulled his arm out all bloody, as there was a mama raccoon with three or four pups. (Even though a raccoon is a member of the cat family, her offspring are considered pups.) It took about 200 stitches to fix his wound.

Raccoons carry several diseases. The most notorious of these diseases are rabies, distemper, and several that are not as common. So, my best advice is to stay away from these little buggers. They are very unpredictable animals as they go into hibernation in October and very early November. They hibernate in oil and gas flues, in fireplaces behind the damper cover, under mini barns, in culverts, barns, and people's attics.

So no raccoons will be here in the road after November — road kill, that is. They'll not leave a habitat unless chased out by a human or dog. Raccoons will only fight a dog if cornered. Most of the time, they will shy away from a dog.

I suggest you never feed a raccoon, as they will always come back for more. Chicken, steak, and pork chop bones are their favorite, as I've taken out many of these bones from fireplace smoke shelves.


I've been lucky over the years as a chimney sweep, as it was only dogs and cats that bit me. Oh, and I was bit by a squirrel and cockatoo, but nothing serious.

It'll be the latter part of March or early April before they come out of hibernation. At this time, they start mating. I've taken out pups twice. I brought them to a lady in Carmel to raise and let go in the wild after about three or four months old — a very humane person she is.

Well, that's all for now. See you sometime.
